1. It is with deep sadness and regret that I announce the death of **Mrs. Gertrude Janeway**, who passed away at her home on January 17, 2003. Mrs. Janeway was the last recognized widow of a Union veteran of the Civil War. She was 93 years old and was still living in the three-room log cabin where she had lived most of her life. Mrs. Janeway was an Honorary Member of the Sons of Union Veterans of the Civil War

2. Mrs. Janeway was the widow of John Janeway, whom she married when she was 18 and he was 81. Her husband was John Janeway, who served as a Private with Company B, 14<sup>th</sup> Illinois Cavalry under the name of John W. January. Private January was mustered into service on June 21, 1864. He was captured by the enemy on July 31, 1864, and was held as a Prisoner of War in Andersonville, Georgia, and Florence, South Carolina, where he suffered greatly. Private Janeway was mustered out on July 31, 1865, at Nashville, Tennessee.

3. This is truly the passing of an era. In honor of the memory of Mrs. Gertrude Janeway, I do hereby order the draping of the Department Charter and all Camp Charters until February 17, 2003. Rest in peace, Mrs. Janeway.
