**JOHN CLEM AWARD  
FOR ACCOMPLISHMENTS BY  
JUNIOR MEMBERS AND JUNIOR ASSOCIATES**

1. In accordance to Department By Laws article XII section A, I hereby institute the John Clem Award for use in recognizing accomplishments of Junior Members and Junior Associates.
2. This award may be given to a Junior Member or Junior Associate for service in the preservation of the memory of the Grand Army of the Republic and the men who fought to preserve the Union during the Civil War.
3. John Clem attached himself to the Twenty-Second Michigan Infantry in the fall of 1862 while he was eleven years of age. Two years later, he was allowed to enlist and was promoted to sergeant, becoming the youngest enlisted man in the army. That same year, John Clem served at the Battle of Chickamauga, where he was credited with shooting a confederate colonel. Clem also had the distinction of being the last Civil War veteran serving on active duty when he retired as a Major General on August 29, 1916.
