PROCEEDINGS OF THE TWENTY-SEVENTH ANNUAL ENCAMPMENT DEPARTMENT OF KANSAS SONS OF UNION VETERANS OF THE CIVIL WAR March 18, 2023 Winfield, Kansas

1. As required by Chapter II, Article III, Section 1 of the Regulations of the Sons of Union Veterans of the Civil War and by Article VI, Bylaws of the Department of Kansas, SUVCW, the Twenty-Seventh Annual Encampment of the Department of Kansas, was held on March 18, 2023, in Winfield, Kansas.

2. The Encampment was called to order at 10:30 AM by Department Commander Robert D. Boyd II. This followed the memorial service. The opening was conducted per the Ritual and Ceremonials of the Order.

3. The Department Secretary called the roll of officers, and reported all officers present:

Department Commander Robert D. Boyd II, PCC, Camp 9, present. Senior Vice Department Commander Thomas E. Schmidt, PDC, Camp 1, present. Junior Vice Department Commander Conrad M. Fisher, PCC, Camp 16, present Secretary Alan L. Russ, PDC, Camp 16, present Treasurer. Rocky L. Bartlow, PDC, Camp 16, present. Council Member Walter H. Schley Jr., Camp 5, present. Council Member Michael A. Todd, PCC, Camp 4, present. Council Member Roy A. Lafferty, PDC, Camp 4, present. Immediate Past Department Commander K. Kirk Nystrom, PDC, Camp 16, absent. Patriotic Instructor Steve Hamlin, Camp 1, absent. Chaplain Kent M. Melcher, PDC, Camp 10, present. Graves Registration Officer William J. Stoker, PCC, Camp 5, present. Civil War Memorials Officer Rocky D. Ansell, Camp 9, absent. Historian Joshua S. Young, Camp 5, present. GAR Records Officer Blair D. Tarr, Camp 16, absent. Color Bearer Bridger P. Keyes, Camp 9, absent. Guide Michael A. Todd, PDC, Camp 4, present. Guard George E. Goff, Camp 4, present.

4. Commander Boyd then appointed the following brothers for the encampment:

Patriotic Instructor Dale L. Rouse, PCC, Camp 1 Color Bearer Barrett E. Young, PCC, Camp 9.

5. Commander Boyd welcomed Past Commander-in-Chief Brian C. Pierson, Department of Oklahoma, to the encampment as the National Representative. PCinC Pierson briefly addressed the encampment.

6. The Chaplain's prayer and the Pledge of Allegiance followed.

7. Commander Boyd declared the Twenty-Seventh Annual Encampment of the Department of Kansas, Sons of Union Veterans of the Civil War, to be open for the transaction of such business as may legally and properly come before it.

8. Prior to presenting the Credentials report, Secretary Russ noted that one of the delegates for Pvt John N. Eckes Camp No. 10 was not present, and the camp had two alternate delegates in attendance. He inquired of Camp Commander Chrisman as to which of the alternates he wished

to be allowed voting status as a delegate. Commander Chrisman designated that Brother William K. Mueller was to be changed from alternate to delegate.

9. The Credentials report was presented. Brothers signed in as they arrived at the encampment. A quorum was declared to be present. Summary of attendance is shown below. Appendix A contains the listing of attendees and their status.

10. Commander Boyd appointed PDC Alan L. Russ (Chairman), PDC Michael A. Todd, and PDC Roy A. Lafferty to the encampment bylaws committee.

11. Commander Boyd appointed PDC Rocky L. Bartlow (Chairman), PDC Thomas E. Schmidt, and PCC Conrad M. Fisher to the Encampment and Resolutions Committee.

12. Commander Boyd informed the Encampment of "housekeeping rules" to be used during the meeting.

13. The Department Officer and camp reports were received, reviewed, and compiled prior to the encampment. The reports did not contain any recommendations requiring action by the encampment. Each officer was asked in turn if there were any additions, deletions, or corrections to their report.

a. Treasurer Rocky L. Bartlow advised that two items had exceeded their planned amount. One was the cost for the Lincoln Tomb Ceremony wreath, and the other was the cost of printing for the Encampment. Both were referred to the Encampment Resolutions and Officer Reports Committee for recommendations.

14. Secretary Russ noted for the encampment that none of the reports contained recommendations requiring action by the encampment.

15. Secretary Russ reported the correspondence which had been received has previously been distributed to all officers and camp secretaries, except for the following:

a. On January 6, 2023, Brother Walter H. Schley Jr. notified the Department Secretary and the Department Commander that he wished to resign as a council member effective with the end of the 2023 Department Encampment due to other obligations. Brother Russ noted that Brother Schley had served as a Council Member for five years, and his participation was truly appreciated.

b. On February 11, 2023, National Secretary Daniel Murray sent an email to the Department which contained the final report of the National Special Committee on Membership Qualifications. This email directed that the report be shared "with every Brother of your Department and bring it to the floor of your Department Encampment to vote to either support or reject the individual

recommendations of the report..." The results are to be reported to the Commander-in-Chief via the National Secretary. The report was distributed to the camps via email on February 12, 2023.

c. Brother Russ then moved the Department Commander to take a vote of preference by item on each of the five recommendations contained in the February 5, 2023, report of the National Special Committee on Membership Qualifications. Such vote on each of the five recommendations, by count for and against, shall be forwarded through the National Secretary to the Commander-in-Chief. Furthermore, such vote SHALL NOT be binding on the voting members of the Department Encampment in attendance at the National Encampment to be held August 4 and 5, 2023, at Nashua, New Hampshire.

d. The above motion was seconded. Each of the five recommendations from the report were read and a vote was taken after each of the recommendations was read and discussed. The results of the voting were as follows:

16. PDC Michael Todd presented the report of the nominating committee. Nominations were, as follows:

17. Commander Boyd then announced the Department awards and certificates and asked PCinC Pierson to present them.

18. Secretary Russ, as chairman of the Department Bylaws Committee, presented the committee report, along with the recommendations of the committee.

a. The proposed amendments were submitted to the encampment for vote. A two-thirds vote of approval for amendments 2023-01 through 2023-07 was received, with all amendments being adopted with the required two-thirds margin of votes cast.

19. At 12:05 PM, Commander Boyd directed the Chaplain to close the Bible for lunch recess.

20. The encampment was called back into session at 1:00 PM.

21. LGAR members, led by Department President Nancy Durbin, introduced themselves to the encampment, along with DUVCW member Linda Hare.

22. Secretary Russ, as chairman of the Department Bylaws Committee, continued with the the committee report, addressing the remaining amendment.

a. Proposed amendment 2023-08 was submitted for voted. The committee then moved to amend the proposed amendment, as follows:

Item 3b(2) to be amended to read (proposed amended wording underlined) (2) The Department of Kansas Social Media Manager.

And to add Chapter V, Article II, Section S, subparagraph 6, as follows:<u>6. The Department Signals Officer shall be the Chairman of the Department Technology</u> <u>Committee.</u>

The motion to amend passed. The motion, as amended, then passed with the required twothirds margin of votes cast.

23. Brother Walter Schley presented the report of the Department Council Members and declared the financial records had been reviewed by the council and appeared to be in order.

24. Commander Boyd then took the encampment into new business.

25. Brother William Stoker moved the additional cost of \$23.60 for wreath for the Lincoln Tomb Ceremony be approved for payment. Motion was second. Under discussion, Brother Russ pointed out that the encampment is overruling an action of the Department Council. Motion carried.

26. Brother Lane Smith moved the additional cost of \$17.16 for additional printing expenses for the Department Encampment. Motion was seconded. Motion carried.

27. Brother Schmidt moved the two payments which were just approved be paid from the unused portion of funds allocated for the Department Encampment. Motion was seconded. Motion carried.

28. Commander Boyd addressed the encampment with regards to the 2023 National Encampment, to be held in Nashua, New Hampshire, August 3 through 6. The business meeting is to be held on August 4 and 5. The following past department commanders stated their intention to attend: Commander Boyd in his status as PDC, PDC Schmidt, PDC Bartlow, PDC Russ, PDC Lafferty, PDC Melcher, and PDC Todd.

29. Commander Boyd called for nominations to elect delegates to the 2023 National Encampment.

30. There were no nominations for delegates, and, therefore, none elected.

31. PDC Russ moved all remaining Brothers of the Department of Kansas in Good Standing at the time of this Encampment are hereby elected as Alternates to the next annual National Encampment of the Sons of Union Veterans of the Civil War. Motion was seconded. Motion carried.

32. Commander Boyd asked if any camps were willing to host the 2024 Department Encampment. Commander Michael Heck, Sgt. Samuel J. Churchill Camp No. 4, Lawrence, advised that Camp 4 wished to host the encampment at Constitution Hall at Lecompton. He then moved Camp 4 be designated as the host camp, with the encampment on April 6, 2024, and April 13, 2024, as a back-up date. Motion was seconded.

33. PDC Russ moved the department per diem be set at \$5.00, effective January 1, 2024. Motion was seconded. Motion carried.

34. Brother Russ moved that this, the Twenty-Seventh Annual Encampment of the Department of Kansas award the Distinction and Honor of Emeritus to Brother Douglas E. McGovern, P.C.C., with its accompanying authority to permanently wear the badge of a Department Elected Officer. Motion was seconded by Brother Schmidt. Motion carried.

35. Brother Bartlow, as Chairman of the Encampment Resolutions and Officer Reports Committee, reported that the items which had been referred to the committee had already been handled as new business.

36. Commander Boyd requested PCinC Pierson take a few minutes to address the "Deed of Conveyance", as there existed much confusion concerning it. In addition to his discussion, a copy of the National Policy on the Deed of Conveyance was distributed to each attendee.

37. Commander Boyd proceeded with the nomination of officers. The following brothers were nominated for the indicated office.

38. There being no additional nominations for the positions, nominations were closed.

39. In accordance with Roberts Rules of Order, the following candidates for a position which was not contested were declared by Commander Boyd as elected. ¹

Department Commander - Thomas E. Schmidt, PDC, Camp 1 Senior Vice Department Commander - Conrad M. Fisher, PCC, Camp 16 Junior Vice Department Commander – Kent M. Melcher, PDC, Camp 10

40. PDC Bartlow moved to accept the proceedings of this encampment as approved when they are approved by the Department Council. Motion was seconded. Motion carried.

41. There being three candidates for two Council Member positions, it was necessary that voting be conducted for the positions.

a. Brother Russ explained the procedure for voting in accordance with the National Regulations. At this time, Brother Boyd declared a five-minute recess to allow the camps to caucus for the vote for Council Member (2-year term ending 2025).

b. After the recess, Secretary Russ called the roll of attendees to verify the number of votes for each camp.

c. Secretary Russ called the roll of camps for their votes. Voting for Council Member (term ending 2025) was as follows: 22 votes for Brother Roy A. Lafferty; 0 votes for Brother James H. Graves; 3 votes for Brother Dawson R. Ballard. Commander Boyd declared Roy A. Lafferty duly elected as Council Member, with the term ending 2025.

d. Camps were again given several minutes to caucus before voting for the one-year term of Council Member.

e. Secretary Russ called the roll of camps for their votes. Voting for Council Member (term expiring 2024) was as follows: 22 votes for Brother James H. Graves; 3 votes for Brother Dawson R. Ballard. Commander Boyd declared James H. Graves duly elected as Council Member, with the term ending 2024.

42. There being no further business to come before the encampment, Commander Boyd turned over the gavel to PCinC Brian C. Pierson for the installation of officers. PCinC Pierson relieved Brother Boyd of his command.

43. Commander-elect Thomas E. Schmidt was asked to provide a list of appointed officers to the secretary. The secretary read those elected and appointed, to wit:

46. Commander Thomas E. Schmidt proceeded to close the Encampment, as per the Ritual and Ceremonials of the Order. The Encampment was declared closed at 3:40 PM.

The largest thing that was accomplished was the web site for the Department of Kansas. Thank to Senior vice Commander Tom Schmidt and PDC Kent Melcher, we are up to date and thriving. Everything changes and we also must change.

Thanks also to the Department of Georgia, Department of Oklahoma, Department of Missouri, and the Department of Nebraska for your support, we will never forget.

Tom obtained permission from the family to take the data and pictures from the old website and incorporate it into the Department's new website. Black Cat Creative (formerly Tyler Stove Design) was brought in to accomplish this large task in the middle of November 2022. As of February 1, 2023 this project has been completed. To have this information in place and functional is a great addition to our website.

Brother Kent Melcher is handling the updating of the camp pages for Winfield, Topeka and Humboldt. Brother Tom Schmidt is handling camp pages for Wichita, Lawrence and Olathe.

Brother Terry Justice has done an amazing job of researching the history of the cannon which was given to the Sedan G.A.R. post, and therefore is legally the property of the SUVCW. As brother Justice has said, the gun belongs in a museum.

The Camp participated in Memorial Day and Veterans Day observances, including marching in the Arkansas City Veterans Day parade. Our brothers have manned booths at local community events. At an Eagle Scout Court of Honor, the Camp presented the Scout with the SUVCW recognition certificate.

Department Standing Bylaws Committee - Alan L. Russ, PDC, Chairman

1. The Department of Kansas Bylaws Standing Committee was appointed by Department Order No. 2, dated May 27, 2022. The committee consists of the following brothers of the Department:

Alan L. Russ, PDC, Chairman – Old Abe Camp 16 Conrad M. Fisher, PCC, Member – Old Abe Camp 16 Kent M. Melcher, PDC, Member – Pvt. John N. Eckes Camp 10 Thomas E. Schmidt, PDC, Member – Corp. Patrick Coyne Camp 1 Michael A. Todd, PDC, Member – Sgt. Samuel J. Churchill Camp 4 Robert D. Boyd II, PCC, Member (ex officio) – Humboldt Camp 9

2. The committee remotely met on October 3, 2022, and December 5, 2022, to consider proposed amendments to the Department Bylaws. All proposals were reviewed and discussed by the committee and will be submitted to the 2023 Department Encampment with the indicated recommendations of the committee.

3. As required by Department of Kansas Bylaws, Chapter IX, Article III, Section A1, these proposed amendments, along with the recommendations of the Department Bylaws Committee, are being distributed to the various camps of the Department for their review at least ninety (90) days prior to the Department Encampment.

PROPOSED AMENDMENT NO. 2023-01

SOURCE: Proposed by Department Bylaws Committee

DISCUSSION: Prior to the revision of the SUVCW "Ritual and Ceremonials" in 2015, it was titled "Rituals and Ceremonies." The previous editions were the basis when the change to the Department of Kansas Bylaws was made to then Article IV, Section K, of the Department Bylaws. This was not corrected in 2016 after the change in title. The following amendment is recommended to correct the error in the Bylaws.

RECOMMENDATION: The committee recommends this amendment be adopted.

CHAPTER II CAMPS

Article IV. USE OF RITUAL AND CEREMONIES CEREMONIALS AT CAMP MEETINGS.

The Ritual and Ceremonies Ceremonials of the Order are an integral and historic part of the Sons of Union Veterans of the Civil War. As such, all Camps within the Department of Kansas shall conduct meetings as provided in the Rituals and Ceremonies Ceremonials of the Order, except when circumstances are prohibitive.

PROPOSED AMENDMENT NO. 2023-02

SOURCE: Proposed by Department Bylaws Committee

DISCUSSION: Department policies exist as a means of governing and direction one level below the Department Bylaws. They are <u>not</u> incorporated into the Bylaws by reference.

This amendment formalizes and clarifies the process for placing policies into effect. It allows for the establishment of interim policies between department encampments and establishes that a policy requires the approval of a department encampment to become a permanent policy.

This amendment also establishes responsibility for reviewing potential changes to policies, along with establishing a requirement that policies must be reviewed at least once every four years.

RECOMMENDATION: The committee recommends this amendment be adopted.

CHAPTER IX GENERAL

Article I: RULES, REGULATIONS, AND POLICIES

All rules, regulations, and policies of the Department of Kansas, and any subsequent amendments or modifications thereto, shall require the approval of the Department Commander or a Department Encampment, and they can be used to manage the Department in support of these Bylaws.

Section A. POLICIES OF THE DEPARTMENT OF KANSAS.

1. The Department Commander may establish formal interim policies for the Department of Kansas, subject to approval of the Department Council. Such interim policies will expire as of the next Department Encampment unless they are accepted and approved by the next Department Encampment.

2. It shall be the responsibility of the Department Standing Bylaws Committee to review policies and submit recommended changes to existing policies to the Department Encampment.

3. Department Policies shall be numbered sequentially, followed by the year approved, as follows: "Policy 01 (2023)."

4. Policies shall be reviewed at least once every four years.

PROPOSED AMENDMENT NO. 2023-03

SOURCE: Proposed by Department Bylaws Committee

DISCUSSION: Department Bylaws do not currently contain provision for a Department Signals Officer. This change adds the position and a description of duties to the Bylaws. It also corrects the wording of the Bylaws for the Eagle Scout Certificate Coordinator to make it match the National Regulations.

RECOMMENDATION: The committee recommends this amendment be adopted.

CHAPTER V DEPARTMENT OFFICERS AND COMMITTEES

Article I: OFFICERS

Section C. APPOINTED OFFICERS.

The appointed Officers of the Department are the Department Patriotic Instructor, Department Chaplain, Department Historian, Department Counselor, Department Graves Registration Officer, Department Civil War Memorials Officer, Department Eagle Scout Certificate Coordinator, Department Signals Officer, Guide, Color Bearer, and Guard. On assuming office, the Department Commander shall appoint all other Department Officers not elected; and may appoint an Assistant Secretary and/or Assistant Secretary/Treasurer. The duties of appointed positions, for which no appointee is designated, shall be retained by the Department Commander. The incoming

Department Commander may delay appointing brothers to the offices of Guide, Color Bearer, and Guard until the next Department Encampment, at which time he will appoint them *pro tempore*.

Section D. TERMS OF OFFICE.

1. The Department Commander, Senior Vice Department Commander, and Junior Vice Department Commander shall be elected for a term of one year. No Department Commander may be reelected to that position for more than three (3) consecutive terms, or if such election will result in him serving as Department Commander for more than 45 consecutive months.

2. The term of office for Department Secretary/Treasurer or Department Secretary and Department Treasurer shall be for three (3) years.

3. Department Council Members will be elected for a two-year term of office, with one position being elected in odd-numbered years and two positions being elected in even-numbered years. Any Council Member vacancy which should occur between Department Encampments shall be filled in accordance with Section F, below. In the case where the term of office for that position would normally extend beyond the next Department Encampment, the remainder of the term shall be filled by a brother elected at that Department Encampment.

4. Appointed officers of the Department shall be appointed by the Department Commander to serve for a period of up to one year, unless sooner relieved. All appointments shall expire automatically at the end of the next Department Encampment, unless otherwise defined by these Bylaws. The appointment or removal of Department Signal Officer shall require the consent of the Department Council.

Article II: DUTIES OF OFFICERS

Section R. EAGLE SCOUT CERTIFICATE COORDINATOR (OPTIONAL).

The Department Eagle Scout Certificate Coordinator shall facilitate the distribution of Eagle Scout Certificates within the Department and compile statistics on the number of certificates requested and the number of certificates presented and transmit this information to the National Eagle Scout Coordinator, and shall perform such other duties as pertain to his office. He shall perform other such duties as described in National Regulations of the Order.

Section S. DEPARTMENT SIGNALS OFFICER.

1. The purpose of the Signals Officer is to serve as the senior advisor on electronic communication technology and manage the assigned resources in such a manner as to reflect positively on the accomplishment of the goals and objectives of the Sons of Union Veterans of the Civil War.

2. The Department Signals Officer should provide the Commander with advice and assistance relative to matters involving communication and technology.

3. The Department Signals Officer shall supervise or serve as the Department Webmaster.

4. The Department Signals Officer should be familiar with and comply with the National Communication Technology policy.

5. The Department Signal Officer should provide assistance, where possible, to Camp Signals Officers

PROPOSED AMENDMENT NO. 2023-04

SOURCE: Proposed by Department Bylaws Committee

DISCUSSION: Department Bylaws have inadvertently carried forward old language describing dues and per capita. Whereas dues are paid by brothers to a camp, per capita is paid by camps to the department and by the department to National. This amendment clarifies the language of the Bylaws.

This amendment also requires that Department per capita shall be paid by camps for dual brothers, in the same manner as National per capita is required.

RECOMMENDATION: The committee recommends this amendment be adopted.

CHAPTER II CAMPS

Article II. CAMP CHARTERS

Section B. SUSPENSION OF CAMP CHARTER.

A Camp failing to pay per-capita dues or neglecting to forward reports within the time specified by law, will be suspended by the Department Commander. Suspended Camps may be reinstated by forwarding reports and paying all arrearages of per-capita dues.

Article V. SUSPENSION, REINSTATEMENT, AND CLOSING OF CAMPS Section A. FAILURE TO PAY PER-CAPITA OR FORWARD REPORTS.

A Camp one year or more in arrears in the payment of per-capita dues and failing or neglecting to forward reports, may be disbanded and the Charter thereof revoked.

CHAPTER IV DEPARTMENT ENCAMPMENTS AND MEETINGS

Article I: DEPARTMENT ENCAMPMENTS

Section I. MEMBERSHIP OF DEPARTMENT ENCAMPMENTS.

The membership of the Department Encampments shall be constituted as follows:

6. A Camp which fails to pay its per-capita dues or other indebtedness or fails to make reports, shall not be entitled to representation at the Department Encampment.

CHAPTER V DEPARTMENT OFFICERS AND COMMITTEES

Article II: DUTIES OF OFFICERS Section D. SECRETARY OR SECRETARY/TREASURER.

The Department Secretary or Secretary/Treasurer, in his capacity as Secretary, shall keep a true and accurate record of the proceedings of the Department Encampment. He shall keep and be the custodian of the files and membership records of the Department, and shall keep such other records in connection with his office as may be required by the Department Commander or the Department Encampment. He shall, by the due date established in National Regulations, make a consolidated report of the Camp Secretary's reports to the Department Commander, and forward a copy of same to the National Executive Director, together with the amount due for per-capita dues and application fees. He shall, by the fifteenth day of each month, forward to the National Executive Director all Camp Status Reports received from Camps for the previous month. He shall forward a report of the election of officers, delegates and alternates to the National Secretary and National Executive Director within the time limits imposed by National Regulations, and perform all other duties pertaining to his office as described in National Regulations of the Order.

CHAPTER VI FINANCIAL MATTERS Article I: FINANCES

Section A. DUES AND REVENUE.

a. The Department shall regulate its own dues per capita and revenues. The amount of said dues per capita shall be set by the Department Encampment and recorded in the official proceedings, thereof.

b. Camps are not required to pay annual Department dues per capita for Junior Members and Junior Associates of their camps.

c. Camps are not required to pay annual Department dues per capita for dual brothers of their camp₅. provided the primary camp of the brother is within the Department of Kansas.

d. Camps are required to pay annual National Per Capita for dual brothers of their camp, if required to do so by National Regulations.

e. Nothing in subsections b, c, and d, above requires a camp to reduce the dues it collects from juniors or dual brothers. Any such reduction in the dues for brothers who fall within these categories shall be addressed in the bylaws of the Camp.

PROPOSED AMENDMENT NO. 2023-05

SOURCE: Proposed by Department Bylaws Committee

DISCUSSION: Robert's Rules of Order Newly Revised (RONR), 12th edition, states the president should always be excluded from the Nominating Committee [RONR (12th ed.), 56:47]. Our bylaws currently read the Department Commander shall serve as member (ex officio) for <u>all</u> committees. In the past, the Department Commander has appointed the Nominating Committee (if desired) and has always excluded himself from the membership. This change codifies previous actions and RONR (12th ed.) into the Bylaws.

RECOMMENDATION: The committee recommends this amendment be adopted.

CHAPTER V DEPARTMENT OFFICERS AND COMMITTEES

Article III: COMMITTEES

Section C. COMMITTEE MEMBERSHIP.

a. Each committee shall consist of no more than five members. The in addition to the Department Commander, who shall serve as member (ex officio) of all committees except the Nominating Committee.

b. The committee chairman shall prepare a report to be presented to the Department Encampment on their activities of the committee for the year. A copy of the committee report shall be forwarded to the Department Commander and the Department Secretary who shall include such reports in the minutes of the Department Encampment.

PROPOSED AMENDMENT NO. 2023-06

SOURCE: Proposed by Department Bylaws Committee

DISCUSSION: This is a relocation of Chapter II, Article V, Section C, to put it with the section dealing with the suspension of camp charters (Chapter II, Article II, Section B). It does not change anything from what currently exists in the bylaws.

RECOMMENDATION: The committee recommends this amendment be adopted.

CHAPTER II CAMPS

Article II. CAMP CHARTERS

Section B. SUSPENSION OF CAMP CHARTER.

1. A Camp failing to pay per-capita dues or neglecting to forward reports within the time specified by law, will be suspended by the Department Commander. Suspended Camps may be reinstated by forwarding reports and paying all arrearages of per-capita dues. [NOTE: The removal of "dues" is addressed in Amendment No. 2023-04]

2. Camps having been suspended may be reinstated upon payment of a required fee of \$25.00 and may retain their original Charter.

Article V. SUSPENSION, REINSTATEMENT, AND CLOSING OF CAMPS Section C. REINSTATEMENT OF CAMPS.

Camps having been suspended may be reinstated upon payment of a required fee of \$25.00 and may retain their original Charter.

PROPOSED AMENDMENT NO. 2023-07

SOURCE: Proposed by Department Bylaws Committee

DISCUSSION: With the revocation of General Order No. 7, as issued by CinC Bruce D. Frail on October 5, 2022, any discussion of electronic submission of supporting documents for applications is premature until such time as the National Encampment acts on the issue in August 2023. As such, proposed modifications to Chapter II have been removed.

The proposed amendment to Chapter 8 is still worthy of consideration in a modified form. References to camp submission of digital copies have been removed, and all applications and supporting document from camps shall be submitted to the Department Secretary in paper form.

RECOMMENDATION: The committee recommends this amendment be adopted.

CHAPTER VIII <u>[Rescinded]</u> DIGITAL RECORDS OF THE DEPARTMENT

Article I. MEMBERSHIP APPLICATIONS

Section A. APPLICATIONS AND SUPPORTING DOCUMENTS IN THE POSSESSION OF THE DEPARTMENT SECRETARY.

1. A paper copy of the applications of active brothers of the Department shall also be maintained; however, support documentation may be maintained in digital form only.

2. Applications and supporting documents of active brothers of the Department which are in the possession of the Department Secretary as of July 1, 2023, shall be digitized and retained by the Department Secretary by December 31, 2024.

2. All applications and supporting documents received as paper copies after July 1, 2023, shall be digitized by the Department Secretary within 45 days of receipt from the camp. These documents shall be maintained as Department records.

3. In the case of any applications or supporting documents of an active member which are not located in Department records by Department Secretary, the Department Secretary shall request the brother's camp to submit a copy to the Department Secretary.

Article II. DEPARTMENT ENCAMPMENT MINUTES/PROCEEDINGS

Secton A. REQUIRED COPIES OF ENCAMPMENT MINUTES/PROCEEDINGS.

1. Proceedings and minutes of all Department Encampments shall be maintained as a paper copy, as these are permanent documents of the Department.

2. The documents shall also be maintained as a digital copy in Adobe pdf format.

Article III. DEPARTMENT ORDERS.

Section A. REQUIRED COPIES OF DEPARTMENT ORDERS.

1. All Department Orders, as issued by the various commanders of the Department of Kansas shall be maintained as a paper copy, as these are permanent documents of the Department.

2. The documents shall also be maintained as a digital copy in Adobe pdf format.

3. Digital copies of department orders for previous years shall be combined into sets for each term of a department commander.

Article IV. STORAGE AND SAFEGUARDING OF DIGITAL RECORDS.

The Department Secretary shall make suitable arrangements, subject to the approval of the Department Council, for a safe and satisfactory means of storing and safeguarding digital copies of the documents listed in Articles I through III, above.

PROPOSED AMENDMENT NO. 2023-08

SOURCE: Proposed by Department Bylaws Committee

DISCUSSION: Create the Technology Committee as a Standing Committee. Because of the ongoing need to keep current on technology issues affecting the Department of Kansas, it is recommended that a Technology Committee be formally created. It is also recommended that the committee by a Standing Committee, not requiring recreation each year. This committee would consist of five members (plus the sitting Department Commander as member ex-officio).

RECOMMENDATION: The committee recommends this amendment be adopted.

CHAPTER V DEPARTMENT OFFICERS AND COMMITTEES

Article III: COMMITTEES

Section E. DEPARTMENT STANDING COMMITTEES

3. DEPARTMENT TECHNOLOGY COMMITTEE.

a. Purpose. The purpose of the Department Technology Committee is to serve as the Department's advisory body on electronic communication technology and the management of assigned resources in such a manner as to reflect positively on the accomplishment of the goals and objectives of the Department of Kansas, Sons of Union Veterans of the Civil War.

b. Membership. The Department Signals Officer shall be the chairman of the committee. He shall request the Department Commander appoint four additional members to the committee, as follows:

(1) The Department of Kansas Website Manager.

(2) The Department of Kansas Facebook Manager.

(3) Two additional brothers of the Department.

c. Activities. The activities of the Department Technology Committee shall include:

(1) Serve as advisory body to the Department Commander and the Department Council on matters dealing with technology options and solutions.

(2) Remain current on emerging technologies and evaluate them for potential use by the Department of Kansas.

(3) Report regularly through the Committee Chairman (Department Signals Officer) to the Department Commander and the Department Council.

(4) Prepare and submit through the Committee Chairman (Department Signals Officer) periodic written reports to the Department Council and an annual written report to the Department Encampment.

Special Nominating Committee – Michael A. Todd, PDC, Chairman

SUMMARY OF JUNE 27, 2022, DEPARTMENT COUNCIL MEETING

1. This meeting was called for the specific purpose to determine future plans for the Department of Kansas website. The meeting was held on June 27, 2022, via Zoom.

2. Commander Boyd informed the Council of the situation with Lee Media. This was followed by lengthy discussion.

It was moved by Brother Bartlow for Brother Schmidt to send an email and letter to Lee Media for clarification of costs and options for their hosting the department website. Motion was seconded by Brother Nystrom. After a brief discussion on the motion, the vote was cast as five in favor of the motion, and none opposed. Motion carried.

SUMMARY OF JULY 14, 2022, DEPARTMENT COUNCIL MEETING

1. This meeting was called for the specific purpose to review the preliminary report of the Special Website Committee and determine future plans for the Department of Kansas website. The meeting was held on July 14, 2022, via Zoom.
